### PROTOCOL I

### (Referred to in Article 11)

#### **ARTICLE 1**

This Protocol shall apply to products that are specified in Article 10 of the Agreement.

### **ARTICLE 2**

- 1. The agricultural products originating in the Republic of Turkey listed in Annex I to this Protocol shall be imported into the Republic of Serbia according to the conditions established in that Annex.
- 2. The agricultural products originating in the Republic of Serbia listed in Annex II to this Protocol shall be imported into the Republic of Turkey according to the conditions established in that Annex.

### **ARTICLE 3**

The Parties shall grant preferential treatment to each other as regards the products listed in Annexes of this Protocol in compliance with the provisions of Protocol II concerning the rules of origin of the Agreement.
