DECISION No. 1/2020 of the JOINT COMMITTEE

Established by the Interim Free Trade Agreement between the Republic of Turkey and the Palestine Liberation Organization for the benefit of the Palestinian Authority

Revising Table I to Protocol I on Exchange of Concessions on Basic Agricultural and Processed Agricultural Products and Fisheries

THE JOINT COMMITTEE,

Having regard to the Interim Free Trade Agreement establishing a Free Trade Area between the Republic of Turkey and the Palestine Liberation Organization for the benefit of the Palestinian Authority (hereinafter referred to as "the Parties", "the Turkish Side" or "the Palestinian Side" where appropriate), signed on 20 July 2004 (hereinafter referred to as "the Agreement"),

Pursuant to Article 7 of this Agreement concerning the exchange of concessions in trade of basic agricultural and processed agricultural products and fisheries between Both Sides;

Taking into account Article 50 of this Agreement, empowering the Joint Committee to decide to amend the Protocols and Annexes to this Agreement;

Having regard to Decision of the Turkey – Palestine Joint Committee No. 1/2011 on Addition of Table 1 to Protocol I on Exchange of Concessions on Basic Agricultural and Processed Agricultural Products and Fisheries;

Having considered the request of the Palestinian Side for increasing the annual duty free tariff quota for the dates of Palestinian origin on importation into Turkey,

HAS DECIDED AS FOLLOWS:
