DECISION OF THE JOINT EFTA-TURKEY COMMITTEE

No. 1 of 2009

(Adopted on 3 December 2009)

AMENDMENTS TO PROTOCOL A CONCERNING PROCESSED AGRICULTURAL PRODUCTS

THE JOINT COMMITTEE,

Noting that the amendments to the Nomenclature appended to the International Convention on the Harmonized Commodity Description and Coding System (HS), which entered into force on 1 January 2007, require adjustments in the HS structure of the Protocol,

Having regard to Article 29 of the Agreement, which empowers the Joint Committee to amend the Protocols and Annexes.

DECIDES:

- 1. The Table to Protocol A shall be replaced by the Table set out at Annex to this Decision.
- 2. This Decision shall enter into force on the first day of the third month after the last Party has deposited its instruments of acceptance with the Depositary, which shall notify all the Parties.
- 3. The Secretary-General of the European Free Trade Association shall deposit the text of this Decision with the Depositary.
