INWARD PROCESSING PROCEDURE

DEFINITION





The inward processing procedure (IPP) is a customs procedure with economic impact; based on the principle that goods not in free circulation are imported temporarily to the customs territory of Turkey for processing operations and re-exporting of the compensating products obtained as a result of processing.







- boosting exports by providing raw materials at the world market prices
- enhance the competitiveness of exporting products in the international markets
- improving and diversifying export markets






Applications are evaluated on the basis of these economic criteria:

- The imported goods should have been clearly determined that are used in the production of main compensating goods,
- Benefiting of IPP should not cause a serious damage to the domestic producers,
- Production process under IPP should have to create an additional production capacity, and increase the competitiveness.

TIME LIMIT (IP Aut. Cert. & Permission)



General rule:

Up to 12 months (depends on the sectors)

Exceptional cases:

Time limit is given in accordance with the period of the project where the goods have more than 12 months production process

(defense industry products, ship building etc.)

Processing operations means any of these:

- the working of goods (including erecting or assembling them or fitting them to other goods)
- the processing of goods,
- the repair of goods (including restoring them and putting them in order)
- the use of goods which are not to be found in the processed products, but which allow or facilitate the production of those products, even if they are entirely or partially used up in the process (production accessories)





Compensating Product: All products resulting from processing operations.

Main Compensating Product: The product that is intended to be obtained within the scope of inward processing.

Secondary Compensating Product: The product obtained as a result of processing operation except for the main compensating product.





Deficiency: Non-economic valued waste which is lost and destructed especially in the form of desiccation, evaporation, leakage or gas leakage during processing operations.
